1 - SUGGESTIONS

Ready to use in 3 simple steps:

- 1. Download the free App "1Control SOLO" on the Apple App Store and Google Android Play Store. If the app is not shown to you on the store. it means that your device does not have the required Bluetooth 4 interface. In that case go to our help center available also at www.1control. it/support
- 2. Copy the remote control by simply bringing it close to the original device. If it does not occur correctly go to www.1control.it and check if its in the list of compatible remote controls. If you cannot find it please go to our website www.1control.it/support.
- 3. Position it near the gate and use the app to open and close it. If it does not work go to www.1control.it for suggestions on how and where to place the device or go to www.1control.it/support for help.

1Control SOLO is capable of duplicating the remote control frequencies that range from: 433.92 MHz - 868.3 MHz, fixed code and rolling code. Due to these characteristics that make it unique, 1Control SOLO has to adapt to the transmission codes and to the various learning methods that the signal receivers have; it is very important to read these instructions before putting 1Control SOLO to use.

Each remote control has a custom code that is transmitted over a given frequency. In fixed code remote controls this code is always the same, so once copied it is ready for use.

In rolling code remotes the code transmitted varies according to a mathematical algorithm different for every manufacturer and must be recognized by the receiver control. Because of this, after copying a rolling code remote. 1Control SOLO must be associated with the receiver unit in ways that vary according to each specific model.

The app "1Control SOLO" will guide you in this procedure with a simple step by step guide. Also on www.1control.it you can find detailed instructions managing rolling code remote controls with 1Control SOLO.

Once the remote control is copied, place 1Control SOLO within a radius of about 15-20 meters from the gate or garage door. Reduce the distance if there are obstacles such as walls that may interfere with the signal. Other elements that may reduce the signal strength are the characteristics of the smartphone and type of gate/garage.

can be fixed to the wall, using the screws included in the package, or it can be attached to a pole, through the clips, which are also included, once vou have fixed the included pole-mounting accessory to the back of the 1Control SOLO.

Some suggestions

Do not worry about rain or snow: 1Control SOLO is manufactured to withstand any weather (it is certified IP45).

Try to avoid having walls or metal grates between the car and 1Control SOLO. Place 1Control SOLO at least 1 meter from the ground.

Place 1Control SOLO so that you are closer to it in the most typical usage scenario, such as when you arrive home with your car.

You can also keep 1Control SOLO in the car or motorcycle, for example in the glove compartment, taking it around with you: one single 1Control SOLO will help you with all of the gates and garage doors of your family home, vacation house, business offices, etc.! This will allow you not to worry about the distance of 15 meters between you and the 1Control SOLO device

3 - SAFE USE

Please only use batteries indicated in Chapter 4 of this user guide.

The use of any other type of battery may cause damages even to the device including battery leakage, overheating, explosion or fire. The liquid released by the batteries is corrosive and can be toxic. It could

also cause damage to eyes and skin and is extremely dangerous if ingested. In case the liquid of the battery should come into contact with the eyes. wash well with alot of water, do not rub your hands and head immediately to the hospital

Do not subject the device to throws, shaking or bashing.

Do not place the device and/or batteries in a microwave or any other high pressure device.

Do not use the device in areas containing explosive gas: it may not work or catch fire.

Do not place the device on high temperature surfaces: it may not work correctly

Place the device out of children's reach.

1Control SOLO contains wireless transmitters. Although it conforms to all applicable norms and regulations and it is CE marked, like any wireless device, 1Control SOLO may interfere with some electronic and medical devices: please abide by the applicable regulations.

Do not dismantle or modify the device, it could be damaged and not work correctly.

Do not throw the device into the fire, it could ignite and explode.

Do not weld the connections of the device, it could cause leaks, overheating, explosions or fires.

In the event of the device overheating, changing color or changing shape during use, please stop using it immediately and ask for a substitute device.

In the event of the device leaking or emanating bad odors, move it away from sources of heat so as to avoid the risk of fires or explosions.

4 - CLEANING AND MAINTENANCE

Use a soft, damp piece of cloth to clean the device. Do not use alcool, petrol or other similar aggressive products.

5 - GENERAL WARNINGS - REPLACING THE BATTERIES

Please discard exhausted batteries according to all applicable laws, and in any case separately from regular waste. 1Control SOLO requires 2 standard type C 1.5V batteries, which come pre-installed, and guarantee their functionality for at least 18 months.

When batteries need to be replaced, please use only brand new ones. Alkaline batteries are advised since they will last longer. The 1Control SOLO device has a nominal volt tension of 3.3V and a power equivalent to 0.3W

To substitute the batteries

1. Turn upside down the SOLO 1Control device and unscrew the 4 screws using a Phillips screwdriver (also known as crossed screwdriver).

- 2. With the help of a coin remove the top making sure to not lose the seals placed in the screws cylinders. In case of loss or rupture there are two reserve seals available.
- 3 Remove batteries
- 4. Insert new batteries, making sure to place them with the correct polarity, according to the "+" and "-" signs on the battery compartment.

In case you are using non-rechargeable batteries

Using incorrect batteries can lead to leaks or explosions. Use only batteries of the appropriate size (type C, 1.5V) and type (alkaline, zinc-carbon or zinc-chloride)
